All Year Round (AYR) Contract and Fees:

Fees are applicable for 51 weeks of the year including Public and Bank Holidays, with a two-week holiday allowance pro-rata to your child's regular bookings. The holiday allowance means session fees will be charged at 50% providing the required notice of 4 weeks is given in advance via email. Term dates including funded periods and nursery closures will be issued annually. Please review the current Terms and Conditions of our contract for more information. We offer a Long Day Full Week discount for those who are eligible and pay full nursery fees all year round without utilising Early Education Funding, please speak to the Office Manager.

Term Time Only (TTO) Contract and Fees:

Fees are applicable for 38 weeks of the year including any Public and Bank Holidays that fall during the term. Term dates including funded periods and nursery closures will be issued annually. Please review the current Terms and Conditions of our contract for more information.

Early Education Funding for eligible 9 month, 2-, 3-, & 4-year-olds:

The government issued Early Education Funding can be claimed on both the AYR and TTO contracts during the hours of 08:30am to 11:30am (3 hours) and 11:30am to 14:30pm (3 hours). A maximum of 6 funded hours may be claimed daily, the childcare during these times is free of charge. Please see the list of product charges above.

Parents and carers are advised to review the Lower Covey Limited Funding Guidance document for further information about how you can utilise Early Education Funding at our nurseries. **Please note the hourly rate for wrap-around care on funded days is at an increased cost to that of our regular nursery fees, see below.**
